All the UG/PG/ Ph.D students of *Fifth Year (IX Sem)/ Fourth Year (VII Sem) / Third Year (V Sem) / Second Year (III Sem)* of the A.Y. 2026-27 are hereby informed that their upcoming *odd semester classes shall commenced from July 27, 2026 (Monday)*. They should deposit **upcoming odd semester fee till July 11, 2026 (Saturday)** through SVVV-ERP portal via respective student Login only, failing which they shall not be treated as regular students of the class and therefore they will not be allowed to attend the regular classes (theory, practical and tutorial). ***It may be noted that it is mandatory to deposit the fee for registration as a regular student in the next semester of the program.***


The details of Late fee are given below:-

All students are hereby informed to submit the fees for the upcoming odd semester as per the schedule mentioned above. Failure to submit the fees by 11-07-2026 will result in the following consequences:

- You will not be eligible for registration in the upcoming odd semester.
- Your class/lab attendance will not be recorded.
- Late fee will not be waived off in any case.

All concerned students are advised to adhere strictly to the deadline to avoid any inconvenience. The Students who are unable to deposit the semester fee will not be allowed to participate in the academic activities of the upcoming odd semester.
