All **Semester Back (Sem Back) students of Undergraduate (UG) Program** except B.Arch. Program for the Academic Session January-June 2026 are hereby informed that they must complete their registration for the Even Semester with the approval of the respective Head of Institute (HOI) / Director as per guideline of Notification: SVVV/N0249A/2026 dated 1 January 2026

All concerned students are required to deposit the semester fee for the Even Semester **on or before 28 February 2026 (Saturday)** through the SVVV-ERP portal using their respective student login only.

Students who fail to deposit the prescribed semester fee within the stipulated date shall not be treated as regular students (BA Group) of the class. Consequently, they will not be permitted to attend regular classes (theory, practical, and tutorial).

It is mandatory for all eligible Sem Back students to deposit the required fee to register as a regular student (BA Group) in the current Even Semester of the program. The details of Late fee are given below:-



All students are hereby informed to submit the fees for the current even semester as per the schedule mentioned above. Failure to submit the fees by 28-02-2026 will result in the following consequences:

- You will not be eligible for registration in the current even semester.
- Your class/lab attendance will not be recorded.

All concerned students are advised to adhere strictly to the deadline to avoid any inconvenience. The Students who are unable to deposit the semester fee will not be allowed to participate in the academic activities of the current even semester. Those students having **less than 75% attendance** shall not be allowed to appear in the End Semester Examination.

Notification on Introduction of B.A. Group System and Semester Registration

Reference: 1. Regulation: SVVV/R-029/2019 dated May 21, 2019;

2. Regulation: SVVV/R-033/2019 dated June 11, 2019;

3. Regulation: SVVV/R-054A/2024 dated August 1, 2024.

All Concern is hereby informed that the University is introducing the BA Group system with effect from the academic session Jan –June 2026 for all UG Programs, except B. Arch. Programs. The BA Group refers to a system under which a student is permitted to register for an even semester prior to the immediately preceding odd semester. In this system the degree requirements by the students may be completed in Dec-Jan in-stead of Jan –June session.

Eligibility for Registration under BA Group:

1. The student is detained in all the courses of the odd semester of current academic year;
2. The student has earned a minimum of 60% of the total credits of the previous academic year and the student has passed in all the courses of the academic year that is one year prior to the year for which registration is sought.

Students who have appeared in odd semester examinations to fulfill the above requirements are permitted to attend the classes of even semester provisionally. However, students who fail to fulfill the above eligibility conditions after declaration of results of odd semester examination shall not be permitted to appear in even semester examination under BA Group system.

The provisional Registration of students under the BA Group system shall be carried out only with the approval of the respective HoI/Director.

All other rules for the award of degree shall be as per regulations SVVV/R-029, SVVV/R-033 and SVVV/R-054A.
