1. **First Year Students Only** - 90 % & above in 10 + 2 (Aggregate of relevant courses only) - 50% of Tuition Fee
2. **First Year Students Only** - Toppers of Various Boards in 10 + 2 - 100% of Tuition Fee
3. **First Year Students Only** - 75 & above Percentile in CAT, 90 & above Percentile in MAT / XAT/ ATMA/C-MAT -50% of Tuition Fee
4. **First Year Onwards** - Scholarship to the Students of the Institutions Sponsored by Shri Vaishnav Group of Trusts -50% of Tuition Fee or Rs. 25000, whichever is less
5. **First Year Onwards** - Scholarship to Employees and their Wards -50% of Tuition Fee or Rs. 25000, whichever is less
6. **Second Year Onwards** - Merit Scholarships (Top 10% / Next Top 10%) - CGPA 8.5 and above - 75% / 50% of Tuition Fee respectively
7. **Second Year Onwards** - Merit-cum-Means Scholarships (Ten Students) - CGPA 7.5 and above and parental income is 3,00,000/- or less per annum - 25% of the Tuition Fee
8. Teaching Assistanceship (TA) for 04 Years Full Time Ph. D Students- 25000 /- First Two Years / 27000 /- Later Two Years
9. Teaching Assistanceship (TA) for M.Tech. Students (Based on GATE qualified) -12,400 /- per month
10. Scholarship Scheme for the Physically Challenged Students (Five Students) -50% of Tuition Fee or Rs. 25000, whichever is less
11. Scholarship Scheme for the Children of Defence Personnel who had Sacrificed their Lives during Warfare / Anti-Terrorist or Similar Activity (Five Students) -50% of Tuition Fee or Rs. 25000, whichever is less

Eligible students are required to fill and submit scholarship form through ERP portal using their ERP credentials.





Next 10% of the students, who have obtained CGPA of 8.5 and above in a program will be awarded scholarship equivalent to 50% of the Tuition Fee.

**Merit-cum-Means Scholarships (Second Year Onwards)**

Ten Merit-cum-Means scholarships equivalent to 25% of the Tuition Fee will be awarded to the students, whose parental income is Rs. 3,00,000/- or less per annum and have obtained CGPA of 7.5 and above in a program.

**Merit Scholarships/Merit-cum-Means Scholarships (Second Year Onwards)**

This is in continuation of the *Notification: SVVV/N-004/2016* dated August 30, 2016 in connection with the scholarships at SVVV. The following additional points for eligibility shall be that:

- (i) the student has passed in all the courses in first attempt only.
- (ii) the number of students who have appeared in the end-semester examination of the program is 15 or more;
- (iii) the number of students is determined on the basis of rounding off of the 10 percent of the total number of students who have passed first and second semester of the program in single attempt. For example, any figure below 0.5 and above 0.5 shall be rounded off to the lower or higher digit respectively i.e., 22.49 will be read as 22, and 22.50 will be read as 23.
